



## **Aidtrade Referral Program – Terms & Conditions**

### **1. Overview**

The Aidtrade Referral Program (“Program”) allows individuals and businesses (“Referrers”) to earn a recurring commission for referring new customers to Aidtrade.ai (“Aidtrade”, “we”, “us”).

### **2. Eligibility**

To participate, you must be at least 18 years old and legally able to enter into binding agreements. By participating, you agree to these Terms & Conditions.

### **3. Referral Tracking**

Referrals must be made באמצעות a unique referral link provided by Aidtrade. We use tracking technology (e.g. cookies and/or referral software) to attribute referrals. Aidtrade is not responsible for untracked or incorrectly attributed referrals due to technical issues, cookie blocking, or user actions.

### **4. Qualified Referral**

A “Qualified Referral” is a new customer who:

- Signs up to Aidtrade using your referral link; and
- Converts from a free trial to a paid subscription; and
- Maintains an active, paying subscription in good standing.

Self-referrals or referrals within the same business entity are not permitted.

### **5. Commission Structure**

Referrers will receive a recurring commission of **\$20 AUD per month** for each Qualified Referral, for as long as the referred customer maintains an active paid subscription.

Commissions:

- Begin only after the referred customer becomes a paying user
- Cease if the customer cancels, pauses, or fails to pay
- Are not payable on refunded or disputed transactions

Aidtrade reserves the right to modify commission rates with reasonable notice.

### **6. Payment Terms**

Commissions are calculated monthly and may be paid out on a monthly or periodic basis, subject to:

- A minimum payout threshold (if applicable)
- Provision of valid payment details by the Referrer

Aidtrade reserves the right to withhold payments where fraud, abuse, or breach of these Terms is suspected.

## **7. Acceptable Promotion**

Referrers agree to promote Aidtrade in a lawful, ethical, and non-misleading manner. Prohibited activities include:

- Spam or unsolicited messaging
- False claims or misrepresentation
- Use of paid ads impersonating Aidtrade
- Brand bidding on Aidtrade trademarks (unless approved)

## **8. Intellectual Property**

All Aidtrade branding, content, and materials remain the property of Aidtrade. Referrers may only use approved materials or branding as provided or authorised.

## **9. Termination**

Aidtrade may suspend or terminate a Referrer's participation at any time for breach of these Terms or misuse of the Program. Upon termination, any unpaid commissions may be forfeited at our discretion.

## **10. Limitation of Liability**

To the extent permitted by law, Aidtrade is not liable for any indirect, incidental, or consequential damages arising from participation in the Program.

## **11. Changes to the Program**

Aidtrade reserves the right to modify, suspend, or discontinue the Program or these Terms at any time. Continued participation constitutes acceptance of any updated Terms.

## **12. Governing Law**

These Terms are governed by the laws of Victoria, Australia.
